Malfeasance – Notice of intent

Dear Katy Bourne,

As you are fully aware I am a disabled financial services whistle-blower exposing serious crimes including, hacking, fraud, corruption, breaches in data protection, perverting the course of justice, witness intimidation, victimisation, criminal negligence and even file sharing naked pictures of children.

I am also a victim of serious disability hate crimes including, abuse, exploitation, victimisation, intimidation, discrimination, theft & slavery by the criminals I am exposing.

I have also been the victim of corrupt legal representation involving intimidation, manipulation, exploitation, witness intimidation and victimisation (witness tampering) and false accusation / harassment which is being investigated by the Legal Ombudsman, who are also involved in the corruption by colluding to pervert the course of justice via evidence tampering / fabrication of which I have irrefutable evidence.

I have tried to obtain justice via police services and have been met with corruption, abuse and discrimination by officers who openly admit to aspiring to sexually exploit vulnerable women or make excuses for those committing these crimes, lie, deceive, pervert the course of justice and are guilty of dereliction of duty.

All of which I have the evidence to prove and of which you are fully aware, as I have written to you twice requesting assistance (02/05/2018 & 03/07/2018) to ensure I received the police services I am entitled to and was even given assurances from your assistant Louise Gilbert via a telephone conversation that this would be dealt with and a letter advising I escalate my complaint to your PSD, which once again was met with further corruption and denial of police services, that can be evidenced.

All I have ever received is discrimination, corruption and malfeasance by you, your office and your police force as well as Victim Support!

This is unacceptable and I therefore give you notice of intent.

Your failure to act when your police force is clearly involved in serious corruption, collusion with criminals and the wilful dereliction of duty to deny a disabled victim of serious disability hate crimes the services and assistance they are entitled to in order to obtain justice for the abuse they have suffered, will not be tolerated and is blatant malfeasance / misfeasance which will be fought tirelessly until justice is served.

No further notice will be given for you to provide the services I am entitled to in order to obtain justice for these crimes and demonstrable corruption.

Please note, I am but one of a conglomerate of aggrieved individuals all of which have their own case, including evidence, of corruption against Sussex police and the failure of you to act upon it.

I also have over 2,000 signatures (and growing) on my petition to bring a change in the law to ensure disabled victims such as myself do not have to go to these lengths in order to obtain the justice they deserve and are entitled to in the face of such blatant police and judicial corruption.
